(1) Course Description

This course is designed to cover all aspects of Good Corporate Governance. It covers a broad issue based on the sphere of influence adopted from the World Business Council for Sustained Development (WBCSD) to accommodate the unique environment in Indonesia. In the core business operation, it covers the internal Corporate Responsibility in implementing high degree of control in labor standards, health and safety, waste management, consumption of water, programs for workers and family on health and safety, employee's engagement, and development. In addition to covering the internal corporate responsibility, GCG goes further to influence their business partners. This will show corporate impact on the societies and SME's through the value chain development. Some of the indirect influence toward business partners can be seen in the form of labor standards, indigenous people's rights, business ethic, and operational excellence and without good GCG could have caused issues such as bribery, social inequality, etc. This in turn will have a direct influence to the environment, market and community. This direct influence can be seen in the creation of the market and communities conducive for growth. It may also result in pollution, bribery and corruption, if the corporation failed to implement a sound Good Corporate Governance. The influence of company toward government indirectly will be in the form of laws and legal regimes, framework conditions and infrastructure. These internal Corporate Responsibility and both the External Corporate Social Responsibility are governed and implemented in a Good Corporate Governance (Urip, 2010).

'Business Ethics' is a significant element in implementing a Good Corporate Governance.
